RULES AND REGULATIONS

1. **ORGANISERS** : Focussed Event Management Pvt. Ltd.
2. **VENUE** : Chennai Trade Centre, Chennai
3. **EXHIBITION DATES** : June 10-12, 2011.
Timings 10.00 am to 6.00 pm
4. **EXHIBITION TARIFF** :
Bare Space : ₹. 8,000/- per sqm. (Min. 30 sqm.)
Shell Scheme : ₹. 8,500/- per sqm. (Min. 9 sqm)
Registration / Admin fee : ₹. 2,500/-
Premium Stall—extra for 2 / 3 side open
Mezzanine construction charges will be applicable.
5. **SPACE BOOKING** :
Bare Space : Organisers will allot only chalk marked bare space. All extra items such as carpet, power and others will be requisitioned from the organizer.
Shell Scheme Stall : Stalls will be provided with partition walls, carpet, name fascia, and with standard furniture like 1 table, 2 chairs, 3 spotlights, 1 socket (220V/50Hz) per 9 sqm booth. Equivalent furniture for larger stalls in proportion.
6. **APPLICATION FOR PARTICIPATION**
Prospective exhibitors should apply for space/stall on the prescribed "Contract of Participation" together with payment of 25% against booking and Balance on or before 31/12/2010.
Booking closes on May 15, 2011.
7. **ACCEPTANCE OF RULES**
The organizers of their authorized representative, have the sole authority to enforce all the rules and regulations pertaining to Automotive Engineering Show 2011. Their decision will be final and binding in all respects for all concerned.
In case it becomes necessary to hold the event at a different venue, organizers will have the sole authority to issue corresponding notification of alteration which replace the confirmation of acceptance.
The execution of the application and participation contract and its reception by Focussed Event Management Pvt. Ltd. is deemed conclusive evidence of the applicants agreement to pay the full fees due from that moment.
The application and participation contract once entered into cannot be cancelled by the applicant.
By booking space at Automotive Engineering Show 2011 exhibition, the exhibition undertake to adhere to all the rules and regulation laid down by the organizers or to be framed from time to time.
All dispute will be subject to Mumbai Jurisdiction.
8. **CANCELLATION**
Cancellation of participation or reduction in the space/stall booked by the exhibitor will not be permitted and no refund will be paid to the exhibitor on this account.
9. **ALLOCATION OF SPACE**
Details of stall allotment will be communicated to the exhibitors appropriately. Organisers reserve the right, should circumstances so necessitate, to change the position, dimension or area of the stalls. In such an event, as much advance notice as possible will be given to the exhibitors.
10. **GUIDELINES**
The organizer will issue detailed guidelines relating to exhibition timings, stall area utilization, approval of layout plans, time table for the stall construction, procession and dismantling other facilities and their costs etc. The exhibitors will have to follow these guidelines strictly.
Possession of space / stall will be given as stated above provided there are no outstanding dues from the participants.
The transport of exhibits for display stand, storage of empty packaging material the use of the lifting and conveying equipment the employment of stall for packing and unpacking, for erecting and dismantling exhibits, the re-packing and any other related activities are all exclusively the responsibility of the exhibitor. Liability of any nature whatsoever of the organizer in this connection cannot be accepted. An official forwarding agent will be appointment by the organizer for the handling of all carrier activities.
Regulatory requirements pertaining to material transport such as Octroi, etc. for the purpose of exhibition will be detailed in this separate document.
11. **DAMAGE CAUSED BY EXHIBITORS**
After closure of the exhibition, stall area to be restored to its original condition. Exhibitors will be required to make good all damages caused to the floor, building or exhibition stall structure, equipment by repairing the same or paying the cost specified by the organizer before the closure of the exhibition at the exhibition ground.
12. **LIMIT OF LIABILITY**
Organisers are not liable in any form for any loss or damage to exhibitors' property on the exhibition site or injury to their personal and visitors. Exhibitors agree to refrain from making any claim on the organizers and to indemnify them against any claim by third party arising out of the exhibitors' conduct.
It is advisable that participants insure their exhibits, display material against loss, damage, theft, fire or any cause whatsoever. They should also obtain third party insurance cover for construction period, fair period and dismantling period.
13. **LOCAL AND SITE REGULATIONS**
Exhibitors agree to abide by the local and site regulation with safety, law and order etc. The organizers will take necessary action those who do not comply with regulations.
14. **SECURITY DEPOSIT**
Exhibitors are required to pay security deposit—10% of the total stall cost. Security Deposit shall be returned to the exhibitors after 3 months of exhibition. Deduction, if any claim for damages and other recoveries.
15. **FORCE MAJEURE**
Under the conditions of force majeure also include strike, lock-out, closure, riot, natural calamities, the organisers reserve the right to alter the opening dates and duration of even cancel the entire exhibition. In case of change in dates and duration of the exhibition, the rules and regulations and the agreement between the exhibitors and the organizers will remain unaffected. In case by the total cancellation of the exhibition, the payments made by the exhibitors will be refunded to the exhibitors after deducting the non-recoverable proportionate costs already incurred by the organizers.
